

Privacy Policy

By using this Website, you consent to the terms of this Online Privacy Policy of Jindal Stainless Limited

This Online Privacy Policy ("Policy") lays down the guidelines applicable to personally- identifiable information of all the natural persons who access, use and provide their personally identifiable information ("you") on this website www.jindalstainless.com (hereinafter referred to as the "Website") of Jindal Stainless Limited (hereinafter referred to as "JSL").

Some of the sections, features and functions of the Website may require your personally identifiable information including without limitation your name, address, email address, telephone number ("Personal Information"). However, you can at your discretion refuse to provide your Personal Information, with the caveat that it may prevent you from using such features, sections and functions of the Website.

You must also read and accept our Website Terms of Use as this Policy is incorporated into and is subject to the Terms of Use. Together the Terms of Use and the Policy shall be applicable to and govern your access, use and Personal Information provided by you on this Website.

This Policy does not apply or govern the use by any third party website of any personally-identifiable information that you may provide to third parties through such third party websites linked to our Website. Please be aware if you choose to visit such third party websites, you should contact such third parties directly to determine their respective privacy policies as the third party's privacy policy, and not this Policy, will govern your access, use and other activities and any Personal Information you disclose while visiting the third party's websites.

JSL expressly reserves the right to change the Policy from time to time, at its sole discretion, without any prior notice to you or any other person. JSL requests you to regularly check this page for any changes to the Policy and specifically in any case before accessing, using and providing Personal Information during every visit. Your continued use of the Website after any change in the Policy will constitute your acceptance of any such change in the Policy.

The following provides for our practices followed regarding gathering and dissemination of Personal Information for the Website:

Overview

As a part of the normal operations of the Website, JSL may request and collect non-personally-identifiable information and in some cases Personal Information. JSL may use or disclose the Personal Information in compliance with this Policy.

By accepting this Privacy Policy and our Website's Terms of Use, you expressly consent to our use and disclosure of your Personal Information in the manner prescribed in this Privacy Policy.

However, such Personal Information will not be posted in areas of the Website viewable by the public or other users/visitors of the Website.

Accuracy of the Personal Information

The Personal Information provided by you shall be true, accurate, complete, fair, sufficient and reasonable for the purposes for which it has been sought by JSL. The Personal Information shall not infringe intellectual property rights or privacy rights of any other persons.

Use of Personal Information

Our primary goal in requesting and collecting your Personal Information is to provide you with a smooth, efficient and customized experience. This allows us to provide services and features that are most likely to meet your needs, to customize the Website and our services, to make your experience on the Website

easier. We use Personal Information provided by you in the files we maintain about you and the Personal Information obtained from your current and past activities on the Website to provide you with customized services.

Disclosure of Personal Information

JSL may disclose Personal Information only to those of its employees, agents, researchers, advertisers, contractors, consultants, subsidiaries, group companies, joint ventures and affiliated organizations that (i) need to know that Personal Information in order to process it on behalf of JSL or to provide services available at the Website, and (ii) that have agreed not to disclose it to other persons, to the extent permitted by applicable laws. However, due to the existing regulatory environment and framework, your Personal Information may be required to be disclosed to the government, regulatory and law enforcement agencies or third parties under certain circumstances. Further, your Personal Information is also fraught with the risk from certain third parties who may unlawfully intercept or access transmissions or hack the Website or Personal Information; or from certain users or authorized users who may independently abuse or misuse your Personal Information that they collect from the Website in violation of our Website's Policy and Terms of Use. Therefore, although we use the industry standard information security practices to protect your Personal Information, yet it may be exposed to certain risks of which JSL cannot hold any responsibility or liability...

As a matter of policy, JSL do not sell or rent any Personal Information to any third party. The following describes some of the permissible ways in which your Personal Information may be disclosed:

Advertisers: JSL may aggregate personally identifiable information provided by all the visitors/ authorized users and disclose such personally identifiable information in a non-personally identifiable manner to advertisers and third parties for marketing and promotional purposes. However, in these situations, JSL does not disclose to these entities any information that could be used to identify you personally.

Other Corporate Entities: JSL may sometimes share data with third party service providers that provide us with services and/or provide you with services. To the extent that these entities have access to your Personal Information, JSL will ask them to treat it at least as protectively as they treat personally identifiable information they obtain from their other authorized users or members.

Legal Requests: JSL co-operates with law enforcement inquiries and investigation, as well as other third parties to enforce laws relating to matters, such as infringement of intellectual property rights, fraud, cyber incidents and protection of other rights. JSL can (and you authorize us to) disclose any Personal Information about you to law enforcement and other government officials as JSL, in our sole discretion, believe reasonably necessary or appropriate, in connection with any inquiries and investigation.

Research and Audit: Researchers who have agreements with JSL, will be allowed to use your Personal Information to conduct scientific projects to improve the industry's manpower use or in terms of machine use or product generation, processes/ operations etc.

Altering Personal Information

You may change the Personal Information furnished on the Website, by making a written request to JSL for the purposes.

You also have an option to withdraw your consent for use of Personal Information with prospective effect by making a written request to JSL for the same. However, in case of withdrawal of consent, JSL shall have the absolute option and discretion not to provide access to such sections, features and functions of Website and/or not to provide services for which the Personal Information was earlier sought.

We will, however, retain in our files and databases your Personal Information. You have requested to remove or alter in order to use it in some circumstances, such as to resolve disputes, troubleshoot problems, and enforce our terms and conditions. Further, such Personal Information is never completely removed from our databases due to technical and legal constraints including stored "back up" systems. Therefore, your Personal Information will not be completely removed from our databases in response to your requests.

Security Practices and Procedures

JSL will use reasonable security measures to safeguard the confidentiality of your Personal Information, such as "firewalls," "secure socket layers" and other physical and electronic security measures. However, you agree and acknowledge that "perfect security" does not per se exist on the Internet and accordingly not on the Website as well. Accordingly, JSL cannot not guarantee that the integrity of the Personal Information shall be maintained throughout or that the Website is free of viruses, interceptions or interferences despite reasonable security measures being taken by JSL.

Business Transfers

If JSL, its subsidiaries, affiliates, joint ventures or any combination of such, could merge with or be acquired by another business entity or in an unlikely event JSL goes out of business, JSL may share some or all of your Personal Information in order to continue to maintain and provide access to the Website. You acknowledge that such transfers may occur and that any acquirer of JSL may continue to use your Personal Information as set forth in this Policy
